Backprop, Inc. (the "Company") is committed to maintaining robust privacy protections for its users. Our Privacy Policy ("Privacy Policy") is designed to help you understand how we collect, use and safeguard the information you provide to us and to assist you in making informed decisions when using our Service.

For purposes of this Agreement, "Site" refers to the Company's website, which can be accessed at [www.epsilon-ai.com] [or through our chrome application]. "Service" refers to the Company's services accessed via the Site, in which users can use to review GitHub pull requests.

The terms "we," "us," and "our" refer to the Company.

I. INFORMATION WE COLLECT

We collect "Non-Personal Information" and "Personal Information." **Non-Personal Information** includes information that cannot be used to personally identify you, such as anonymous usage data, general demographic information we may collect, referring/exit pages and URLs, platform

types, preferences you submit and preferences that are generated based on the data you submit and number of clicks. **Personal Information** includes your email and GitHub username which you submit to us through the registration process at the Site.

1. Information collected via Technology

You acknowledge and consent that such transfers may occur and are permitted by this Privacy Policy, and that any acquirer of our assets may continue to process your Personal Information as set forth in this Privacy Policy. If our information practices change at any time in the future, we will post the policy changes to the Site so that you may opt out of the new information practices. We suggest that you check the Site periodically if you are concerned about how your information is used.
